## Requirements for Volunteer Drivers

I certify that *(Please initial each point if you agree):*

\_\_\_ I possess a valid (state) driver's license. Please attach a photocopy of your driver's license.

\_\_\_ I will maintain the minimum insurance coverage required by the church for the vehicle(s) listed and only volunteer to drive when such insurance policies and coverage are in force.

\_\_\_ I will advise the church of any change in information provided on this form including, but not limited to, involvement in a car accident in which I am cited, any citations for moving violations, non-renewal of license, termination of license, change of insurance company, change in amounts of insurance coverage, termination of insurance, or change of vehicle.

\_\_\_ Students riding in my vehicle(s) will be seated and in both the front and back seat will be secured with individual working seat belts. (No double belting of children is permitted.) If my car is equipped with front seat air bags I will not allow children who are under age 12, under 4 foot 9 inches tall or under 80 pounds to ride in the front seat. As required by state law, I will have a child restraint seat (car seat) for each child under age 8 or under four feet and nine inches tall. If my car has front passenger seat air bags no child will be seated in the front seat.

\_\_\_ To my knowledge, my vehicle is in safe operating condition (brakes, tires, etc.).

\_\_\_ I will notify the church office if I no longer wish to drive or if I wish to be removed from the Approved Driver List.

\_\_\_ understand that the vehicle insurance (and driver insurance, if vehicle is borrowed) is primary for liability coverage and church liability insurance is secondary. The church does not cover damage to vehicles.
